Old Business:

- 1. Transition Task Force Ted Hakala is here to give us a presentation from the TTF. Grow young, welcome young families with children, develop ministries that reach out to those who are broken by life's circumstances.
- 2. Strategy Discussion Canoeing the Mountains
- 3. Updates from the Safely Regathering Task Force The TF meets twice monthly and is continuing to recommend that Bethany stay is Phase 1: Safer at Home. Building and kitchen guidelines have been established for essential groups to use. The Worship team is using the Phase 1 guidelines to deliver services, both on-line and drive-in.

New Business:

- BIC Motion proposed for Annual Meeting Congregational motion to be presented at annual meeting. CONTINUING RESOLUTION;

C10.08.A20 This congregation may hold meetings by remote communication, including electronically and by telephone conference, as long as there is an opportunity for simultaneous communication. To the extent permitted by state law, notice of all meetings may be provided electronically.

In order to conduct an annual meeting using remote technology and including votes, the following Continuing Resolution was needed to be acted upon by the Council.

Motion by PC/BW to pass the continuing resolution. Discussion. Motion carried unanimously by voice vote.
