Is this taking too much time? The group discussed. The group led this discussion from Dave's questions and Deb's handout.

Annual Meeting Minutes: Motion made to post the annual meeting minutes in draft form right away AD/TH – discussion – none. Motion carried.

Financial Report – Motion made to accept the financials AK – discussion – Dawn presented the current budget numbers to council. Discussion on Wendy's recommendation to pay off the mortgage with the General Gift Fund balance. Motion made to pull approximately \$120K from the general gift fund to cover the payoff balance of our Thrivent Mortgage AK/TH – discussion what will happen to donors who only want to give to the mortgage? Might paying off the mortgage bring in more dollars? Upcoming building projects that can be funded from the building fund if the mortgage isn't coming out of that account each month. Maybe a list for donors on upcoming building projects. A lot of this is communicating to the congregation. Yes –5 No-5. Motion fails. Can Council recommend bringing this back as an agenda item in April after the budget Forum. Motion made to payoff the Thrivent Mortgage within 30 days based on positive feedback from the budget forum AK/JN – discussion – can we extend this to our April 25th meeting? Yes. Motion amended: to Council is recommending to payoff the Thrivent Mortgage with monies from the General Gift Fund. AK/PC – Motion carried

OLD BUSINESS:

Congregational Forum April 3 – congregational informational forums. Thank you to the team for planning these. P Arthur went through the agenda. Discussion about removing the COIVD update; committee agrees we can remove that. Where is Mission and Vision?

DM/TR – discussion – is anything changing with her job description? No, just

removing the "interim" term. Motion carries.

Approve Job Description for Visitation Pastor: - Take home and review. We will take action next month.

Provide Telecommuting Policy as Information Only – Take home and review. We will take action next month.

Parking Lot Bid: Motion made to approve the \$7500 parking lot bid BH/DM – discussion – some clarification of why this is happening. Error from the last time this was fixed, the company will redo the area it did last time but we are adding the area to the east to be fixed while they are here, this represents a cost savings since they will be here anyway. Motion carries

Council Orientation: P. Arthur will try to find some dates to hold a Council Orientation after Easter. Orientation could include some conversations/reviews of Bethany's financials.

Summer Worship/Tent Update: We have a donor who is paying half the tent and Trust Fund is paying the other half. The tent will be 3x larger than last year. Tent will be here June – August. Property will work on the grass/turf issues.
