Model Constitution Updates – From time to time the model constitution issued by the ELCA is reviewed and changes are made. When this happens, each congregation should review its constitution and bring

it into compliance with the ELCA standards. Such changes were approved at the National Churchwide Assembly in 2016.

The NW WI Synod office has reviewed our constitution and made updates to bring us into compliance with the national churchwide body. Bethany has not made any changes in the constitution since 2008. Carol Hakala provided a marked-up copy of the constitution changes and a summary of the key areas changed. It is the intent that the changes be communicated to the congregation and acted on at the Annual Meeting.
